மருத்துவப் பணியில் சைமா

On 25th of March 2007, SYMA in association with Sri Kanchi Kamakoti Sankara Medical Trust in commemoration of their 22nd Anniversary arranged a dental camp at Barathiar Illam. A full fledged team from Meenakshi Ammal Dental College, Maduravoyal, Chennai conducted the camp with enthusiasm. Right from early hours, people thronged the camp in huge numbers. Over 100 persons were screened and offered free consultation & medicines.

The dental team consisted of:

- Dr.Naveen R, Oral And Maxillofacial Surgeon (OMFS), Lecturer
- Dr.Sneha, OMFS, Lecturer
- ◆ Dr.Phanni Kumar, P.G. student in OMFS
- ♦ 10 students of final year B.D.S.

The camp started at 9.30 a.m. and went on till 1.00 p.m. SYMA had sufficiently made the residents aware of the dental camp and many of them had registered earlier; some came direct to the venue where SYMA volunteers ensured registration and other formalities to ensure proper attendance by the team of medical experts. SYMA had earnestly made preparations in providing the necessary infrastructure also. The camp had 2 sections, one section for screening all the patients & the other for treatment. All patients were effectively screened for oral diseases, and the respective treatment options were described in detail to them. As the first line of treatment, basic oral hygiene procedures were explained. The patients who required complicated treatment and equipments were referred to Meenakshi Ammal dental hospital for free treatment. For some identified with decayed hopeless teeth, extraction was done at the camp site itself.

Before extraction, a thorough medical history of the patient was recorded. Patients who had symptoms other medical complications were not treated in the camp as this had to be done in consultation on their illness from

respective physicians. As a part of pre-treatment check up, their vital signs (pulse, blood pressure, respiratory rate, temperature) were checked and recorded. Then patients fit for extraction were referred to the treatment section, were the extraction was done with maximum possible aseptic techniques. They were given necessary medications after the treatment.

Quite often those in the lower strata do not get affordable quality medical treatment. It is for providing health care for such impoverished people and for creating awareness of health, social minded organizations and people strive to conduct such activities. But such efforts can fructify only when the patients provide proper history without concealing any ailments. We also place on record our appreciation for the expert treatment provided by the medical team when a patient developed some complications. The genial Dr. D. Ezhumalai who rushed to the camp within seconds of our call also deserves special mention and appreciation for his gesture.

In all, 103 residents benefited by the camp. Those patients, who were referred to Meenakshi Ammal hospital for treatment, were provided transportation by SYMA and our volunteers accompanied them. Quality treatment without any payment was provided by the hospital.

We really appreciate the dedication and care shown by the young team of Doctors & students of Meenakshi Ammal Dental College, in particular Mr. Jagadish who coordinated the camp with us. We thank Sri Kanchi Kamakoti Medical trust for guiding us properly all along and for being with us. We also thank R Kannan and our other volunteers for helping us in neat conduct of the camp. We appreciate the social responsibility exhibited by the young medicos and thank the Management, staff & students of Meenakshi Ammal Dental College and Hospitals. We pray for success in their profession for the young medicos and for their continuing social responsibility.

EVERY THING IN A NAME - WE OPPOSE REDRAWAL OF CONSTITUENCY.

Under Article 82 of the Constitution, the Parliament by law enacts a Delimitation Act after every census. The Govt. has launched an exercise of redrawal of constituencies and alas, the age old Triplicane could be no more. Residents vividly remember that when the First General Elections were held to the Legilsative Assembly of Madras {combined Madras Presidency} in 1951, there were 309 constituencies. Triplicane had 71594 voters of which 39709 cast their votes and all of them were valid votes. AM Sambandan of INC won by a margin of 2878 votes. We are opposed to the proposal to distribute the constituency among Chepauk, Mylapore and T Nagar constituencies. We will raise this issue at the public sitting proposed to be held at the Centenary hall, Madras varsity on May 22. Likeminded organizations are requested to send letter / mails to the Commission conveying their sentiments and views and speak vociferously on the need for preserving Triplicane constituency. We wish to bring to your kind notice the fact that we have already submitted a detailed representation to the Hon'ble Commission under reference first cited, expressing our deep anguish and objection to the proposed readjustment and delimitation whereby the Triplicane electorate will be distributed amongst Chepauk, Mylapore and T.Nagar Constituencies. We also wish to mention that in respone to our aforesaid representation, the Hon'ble Commission had sent the communication second cited, informing us that we could raise the points in the public sitting that will be held after calling for suggestions and objections from the public through notice in the local newspapers.

Now that the notice has been issued in the local dailies, we wish to humbly resubmit our earlier representation alongwith other letters mentioned above. We also request the Hon'ble Commission to kindly take into account our grievances while taking a final decision in the above matter and also to afford us an opportunity of personal hearing during the propoed public sitting. We also wish to submit that members will also be personally present during the public sitting proposed to be held on 22.5.2007 at University Centenary Hall, University of Madras, Chepauk, Chennai.

Answer to Pg.3: The Indian Air Force (Bharatiya Vayu Sena) is the air-arm of the Armed Forces of India, established on October 8, 1932. It was granted the prefix "Royal" in 1945 in recognition of its services during the Second World War. The prefix Royal was dropped after India became a Republic in 1950. It is the fourth largest air force in the world .Motto (from Italian) is a phrase or a short list of words meant formally to describe the general motivation or intention of an entity, social group, or organization. In western countries, mottos are traditionally written in Latin or Romance languages. The crest of the IAF bears the Ashoka Symbol with Devanagari words "Bharatiya Vayu Sena" and the motto "Nabha Sparsham Deeptam – Touch the sky with Glory".
