HEALTH

With the blessings of Lord and with the help and guidance of Kanchi Sankara Foundation, we have made one significant step forward. Apart from running medical centre providing free consultation, a full fledged clinical laboratory has started functioning in our premises effective from 9th July 2007. Very nominal fees for the tests are charged and only 50% of these fees are charged to the medical centre patients.

The Lab is named after Sri. P.V. Rama lyengar & Smt. Suganthavalli – whose family members have donated funds and medical equipments for the lab. We are thankful to Dr Sridhar and Kanchi Sankara Foundation for their continued support and guidance. The functioning of the lab was made possible by the active involvement, advice and direct help rendered by the renowned physician Dr K Sridhar.

We also place on record our thanks to Mr KV Kumar (KVK Builders) Mr Rajagopal of RR Construction and Rajamani who have helped us to construct the necessary infrastructure for this lab. With your continued support & patronage, we are sure we can further our commitment in betterment of the society.

EYE CAMP

On 15-8-2007, at Sirvi Samaj Bhavan, SYMA in association with Sankara Eye Hospital, Pammal, Lions club of Chennai Venus, Sri Kanchi Kamakoti Sankara Medical Trust and Sirvi Samaj Bhavan organized a free eye camp for detection of cataract. The camp was inaugurated by a great sportsperson TA Sekar. Sekar as a tearway speedster had don Indian colours both in Tests and in ODIs in the early 1980s. He is a level 4 coach and now heads the MRF Pace foundation which is churning out quality pace bowlers for International teams. He impressed everyone with his modesty and straight talk.

Affable and person close to our heart – Dr Sridhar also spoke on the occasion. Around 140 people were screened; 15 persons were identified for cataract surgery. They were taken to Pammal Sankara Eye Hospital and free surgery performed for removal of cataract. We also provided free eye glasses for 30 persons diagnosed in the camp.

We are thankful to Lions Club of Chennai Venus which borne the camp expenses and to the doctors and other staff of Pammal Sankara Eye Hospital for their presence, kindness and medical treatment to the patients.

DIABETES CAMP

We paid homage to Mahatma by conducting a medical camp on 2-10-2007. This camp is for the detection of diabetes. This camp on Gandhi Jayanthi day was organized by SYMA in association with Kanchi Sankara Foundation & Lions Club of Chennai Venus jointly and was conducted at the KSF Lab at SYMA Medical centre.

Diabetes mellitus is a metabolic disorder characterized by high blood sugar levels. It is a condition where the body is unable to utilize and store glucose. Diabetes is the oldest and the most prevalent disorder known to mankind and is more common in middle aged and elderly. However, children and adults are also prone to diabetes.



The camp was aimed at raising the awareness of the people and detecting those with this disorder. Our volunteers teamed up and the registration was a neat process. 110 residents turned up. Urine analysis and blood test (both Fasting & PP) were conducted free of cost at our own KSF Lab.

Experts from Dr V Seshiah Diabetes Care & Research Institute provided consultation. 38 were identified as having this disorder and follow up treatment provided to them.

It was good to see many volunteers, particularly youth teaming up for the social service. We are thankful to Dr Madhuri Balaji and her team for the consultation and to all our associates in making this a success.

DIABETES AWARENESS CAMP

On 24 2 08, SYMA in association with Kanchi Sankara Foundation conducted a diabetic awareness and detection camp in front of Sri Parthasarathi Swami temple. Around 130 persons were screened in random blood sugar check up. 15 persons were found afflicted with Diabetes. The KSF Lab functioning at SYMA Medical centre (Unit-III of SKKSMT) will further monitor those identified as diabetic.

For the facility of the patients, we have introduced new prepaid cards priced at Rs. 100/-. Those buying these cards can have check up for blood / urine (both fasting & PP) four times in a year. Though the cost is very low, we are introducing this for the benefit of poor and needy patients who regularly throng our medical centre.

DISTRIBUTION OF UNIFORMS

The uniform distribution function was a grandiose function – neatly organized and smartly done. On 8th of July 2007, there was hectic activity at the house where Mahakavi Subrahmanya Bharathiyar once lived. The function started on time with the invocation of God. Our President TJ Ramani welcomed the gathering. Our Vice President TA Sampathkumar compered the event.

Nawab Mohammed Ali, His Highness the Prince of Arcot, a well known social activist, was our Chief Guest. Rajesh B Lakhoni, the commissioner was the guest of honour. The Clinical lab of Kanchi Sankara Foundation was inaugurated on the podium and the donors for the lab were honoured.

CHILD FEST 2007

The first week of November 2007 (3rd and 4th to be precise) saw children attend in large numbers. Yes the festivity was Child Fest of SYMA. This annual fete is immensely popular amongst school and school children of the City. This year around 4500 students from around 100 schools participated.

As all are well aware, we have been in the field of Social service for more than 3 decades, striving for betterment of society. Our aim has been to inculcate good qualities to children thereby making them become responsible citizens. Child Fest is one such attempt aimed at imbibing in them the skill sets, confidence and more importantly competitiveness.

We provide a competitive platform for the young citizens to showcase their talents in various fields. There are competitions in the disciplines of Singing, Dancing, Fancy Dress and knowledge. This year we after rounds of deliberations decided to exclude dance competition for the school children of higher classes as the cultural values were seemingly eroding in such a show.



On Saturday, the programme got off to an auspicious start with Mr. R. Seshadri, Regional Manager, G.M. Pens, inaugurating the function by lighting the kuthu vilakku. Singing competitions followed at the main Sudarshan hall. Then we had the drawing competition for the higher classes of 6th to 12th standard. Students of 8th & 9th drew on the caption Uses of Forests, while it was Vision of Nehru for the students of 11th & 12th.

At 11.30 it was written preliminary for the two groups of Quiz. There was good participation from schools vying to claim the honours in the knowledge show. Each school was represented by a team consisting of two and four schools reached the finals which was a grand show in the main hall. There were quite a few enthralled audience for the Quiz this time which gave us some sense of satisfaction. The Quiz was conducted by the team of Mr Sridhar Joshi, Sundar & Rajaraman. The concluding question was of great relevance and significance to our organization. It was the picture of a bird asked to be identified. Any wild guesses?

Well the name of the bird was Syma. It is a genus of a bird in the Alcedinidae family containing the species of Mountain kingfisher and yellowbilled kingfisher.

Then followed the competition for which children in large numbers turned up in a motley of colours and variety of attires representing Gods, freedom fighters and more. It was truly a pleasing sight to see so many children in different costumes.

In a surprise deviation from the customary, the prize distribution for some of the events was organized in the first day itself. We are thankful to the distinguished guests –Mr. R. Seshadri of G.M. Whilst Bosski engrossed the audience with a witty deliverance, Ms Mahathi rendered some mellifluous songs. The Chief Guest Ms Supriya Sahu made an emphatic speech, telling the children a thought provoking story of a bird in the hands of a youngster.

OTHERS FIGHT FOR TRIPLICANE CONSTITUENCY

Under Article 82 of the Constitution, the Parliament Byelaw enacts a Delimitation Act after every census. The Government has launched an exercise of redrawal of constituencies Alas! the age old Triplicane could be no more! We are oppose to the proposal to distribute the constituency among Chepauk, Mylapore, and T.Nagar Constitutencies.

On 22.5.2007, there was a public hearing at Senate hall in the presence of Commission chairman Kuldip Singh and Chief Election Commissioner N Gopalaswamy organized by the Delimitation Commission.

Public, political parties, and religious leaders appealed to the commission reiterating the need for retention of age old constituency. It was made out before the forum that Chepauk was carved out of Triplicane in the 1970s; this constituency housed mathematician Srinivasa Ramanujan, poet Bharathiar, freedom fighters Kothai Nayagi and Satyamurty, Silambu Selvar Ma Po Si, Tamil thatha U Ve Swaminatha Ayyar among others.

Our president also spoke on the need for retaining the constituency and submitted a strongly worded letter.

Recently on 13th Aug the Delimitation commission of India has issued a notification in pursuance of the Delimitation Act 2002 delimiting Parliamentary and Assembly Constituencies in the State.



SYMA-AGM 2007-2008

Going by the Order No. 52, the assembly constituency 19 is now "Chepauk- Thiruvallikeni" consisting of ward nos.79, 81 to 93, 95 and 111. This constituency will now entirely fall under Parliament constituency 4-Chennai Central consisting of Villivakkam, Egmore ,Harbour, Chepauk-Thiruvallikeni, Thousand Lights and Anna Nagar.

We can draw solace from the fact that the name still lingers on and interestingly the Commission has mentioned the name as Tiruvallikkeni (in Tamil) and not Triplicane.
